Registration papers will be filled out after the sale is complete, and will be forwarded to the Buyer when the association has returned them, if not available at time of sale.

1. Should Puppy develop any Life threatening medical disorder, which is confirmed by two unassociated veterinarians, Seller will, upon provision of veterinary reports: Provide a replacement pet quality puppy of same quality sex etc. as soon as such a puppy is available. Any life threatening disorder must happen within twelve (12) months from the date of birth, Buyer MUST return the DOG to SELLER for a replacement puppy.

Buyer will pay all shipping and miscellaneous charges associated with transport of both the puppy back to seller and the replacement puppy to Buyer.

All shipping and transportation expenses are responsibility of the BUYER.

2. If the puppy/dog has been used for breeding in any manner there will be no replacement, no matter any conditions found this contract will be void.

3. The registration paperwork must be fully filled out and signed off on the back giving full ownership back to the Sellers at the time and date of the original sale.

4. Seller shall not be held responsible for the development of disqualifying faults, diseases, viruses or disorders, which are due to Buyers negligence.

5. **There will be no other replacement options considered.**

- **HEALTH GUARANTEE**

1. Seller guarantees that Puppy is in good health and has received appropriate medical inoculations, worming and care. Seller will provide Buyer with a medical records detailing treatment Puppy has received under Seller's care, and any future care Seller feels is essential to Puppy's well being.

2. Seller guarantees that Puppy is free of life threatening diseases or disabilities to my knowledge at this time and as far as the eye can see.

3. At no time will the Seller be responsible or obligated to pay for Veterinary Treatments not agreed upon IN ADVANCE and in this contract.

4. Under no conditions and at no time during the life of the DOG will SELLER pay or assist in paying veterinary expenses after the DOG is purchased, including any such expenses directly or indirectly related to any inheritable/genetic defects.

5. There are certain disorders that may be caused by environmental factors, for example: Coccidia, kennel cough, cancer (Cancer can be genetic, environmental or just a random mutation), demodetic mange, scabies, growths, allergies, and other autoimmune system disorders that are not covered in this guarantee. Coccidia & Kennel Cough, are common in puppies that are shipped and is caused by bacteria. Both are not life threatening and are easily treated. Kennel Cough is like a common cold and must run its course. However, due to complex genetic interactions and environmental factors beyond our control, we cannot guarantee that a puppy purchased from us will be free of genetic disorders. Should a puppy be found to have such a genetic disorder, we do provide you with several options listed in this contract. This guarantee does not include uneven bites, or umbilical hernia.

3. *Seller shall not be held responsible for acts of Puppy destruction, or any Puppy acts, and/or dog/dog actions, dog/cat actions as these are the buyer responsibilities once the pup leaves the seller's home, and any acts/actions, which are due to Buyers negligence.*

- **GENERAL**

This also extends to Internet sales across state lines. Any legal fees and court costs shall be the responsibility of the party found to be in default.
